TERMS OF THIS ADOPTION APPLICATION

Read the following carefully.

1. I declare that the information I have provided in this application is true and correct. I, as the adopting person/family, agree to follow the rules and procedures of Paws Rescue. I understand that if any information herein is found to be false that: (1) my application can be refused and/or (2) if a cat/dog I am adopting is already in my care, said cat/dog shall be relinquished to a Paws Rescue Board of Directors Member immediately. All rescued cats and dogs are the property of Paws Rescue and must be returned to Paws Rescue immediately when requested by Paws Rescue Board of Directors Member (hereafter referred to as a Paws Rescue Board Member).
2. I agree that although all cats/dogs are medically examined before placement, evaluated for personality, and every effort is made to match an appropriate cat/dog with each home, no guarantees are expressed or implied as to personality or medical soundness of the dog by Paws Rescue Board Members. I agree to accept the cat/dog "as is". Paws Rescue will not place a cat/dog known to have an unsound temperament. However, no one can predict how any cat/dog will react in a given situation, especially without complete knowledge of the cat/dog's past. Therefore, adopting families are strongly urged to exercise caution when introducing the newly adopted animal into their home. The adopting family should monitor the cat or dog's behavior until the animal has had sufficient time to become fully acclimated to its new environment and the adopting family has had sufficient opportunity to become familiar with the cat/dog's personality.
3. I understand that a Home Check is made prior to being approved for adopting a cat/dog. I specifically give the Paws Rescue permission to conduct a Home Check, as they deem necessary at a time of mutual agreement. It is Paws Rescue's policy to place canines with families who have a secure, fenced-in area at their home. Exception to this policy will be granted on a case by case basis by the Paws Rescue Board of Directors. The animal must never be allowed to run loose or be tethered on a rope or chain. ALL families adopting a dog, especially apartment dwellers, must agree to walk the dog on a leash, as the animals have no regard for the danger from street traffic. Paws Rescues strongly recommends that adopted cats be kept as indoor cats only for their safety and longevity.
4. I understand and agree that any material and substantial breach of these terms shall entitle Paws Rescue to take possession of the cat/dog with or without notice. **If the adopting family cannot, for any reason, continue to keep the cat/dog they must notify a Paws Rescue Board Member immediately. The adopted animal must never be taken to the shelter, pound, or given away to anyone. All cats and dogs are the original property of Paws Rescue and must be returned only to a Paws Rescue Board Member.** If, in the opinion of Paws Rescue Board Members, conditions warrant removal of the cat/dog from the adopting home, Paws Rescue retains the right to remove the animal from the premises without a refund of any expenses paid by the adopting family. This agreement shall be binding upon any party in whose possession the adopted cat/dog may be found. Should a third party be found in possession of the cat/dog without the express written consent of a Paws Rescue Board Member, the same rules will apply, and the dog will be immediately returned to the care of Paws Rescue.
5. All Paws Rescue cats/dogs are taken immediately to the vet when rescued and will be examined by a vet prior to being placed with an adopting family. All rescued dogs/cats will be spayed or neutered prior to adoption.
6. I, the adopting person/family, understand that I will decide whether or not to adopt any particular animal. I will not hold Paws Rescue responsible for any damage, injury, or harm caused directly or indirectly to any person or property by any adopted animal. I assume the risks of being bitten, scratched, injured, made ill, or frightened by dogs, puppies, cats, and/or kittens in connection with my adoption from Paws Rescue. I hereby for myself, my heirs, administrators and assigns, fully, irrevocably and unconditionally release and agree to hold harmless Paws Rescue, its individual members, and any venue at

which Paws Rescue may hold an adoption event, or fund raising event, from any and all known or unknown, anticipated or unanticipated, suspected or unsuspected and/or fixed, conditional or contingent, actions, causes of action, charges, suits, debts, demands, claims, contracts, covenants, liens, rights, liabilities, losses, royalties, costs, expenses (including, without limitation, attorneys' fees) or damages, including but not limited to any illnesses, medical costs, damages to property, persons or other pets, of every kind, nature and description, at law or in equity, in connection with or arising from any action or failure to act on my part or the parts of others when I adopt from Paws Rescue, or for any negligent act or omission by Paws Rescue. Any dispute arising between the parties with respect to this Waiver and Agreement shall be submitted to binding arbitration under the commercial rules of the American Arbitration Association then in effect. The venue for such arbitration shall be the County of Warren, Mississippi. The parties agree to submit to jurisdiction and venue in Vicksburg, Mississippi for purposes of such arbitration.

If I fail to abide by the terms of this Application & Waiver or if I am otherwise unable to meet the requirements for adoption, which are subject to change from time to time, I understand that I will not be allowed to adopt a cat or dog
